I am pleased to report that BankFIRST's financial condition continues to show positive results despite a very difficult economic environment. Enclosed is our December 31, 2009 comparative statement. It should be noted that:

- Our tier one capital ratio of 10.1% (without taking TARP money) is more than double the FDIC "well capitalized" bank guideline.
- The Bank's loan loss reserves now cover our non-accruing loans by over 101%.

In addition to the Bank's strong and improving capital position, 2009 was especially noteworthy for the many recognitions that we received:

- "2009 Best Community Bank in Central Florida" as voted by readers of the *Orlando Business Journal*.
- "2009 Best Bank in Seminole County" as voted by the readers of the *Sanford Herald*.
- "#1 Small Business Lender in Florida" as ranked by the U.S. Small Business Administration.

As we look toward 2010, we plan to continue to expand the Bank and launch new state-of-the-art products and services. In that regard, in February, we broke ground on our new Oviedo Financial Center location at the Aloma Walk Publix Supermarket development, at the juncture of Aloma Avenue and SR 417. 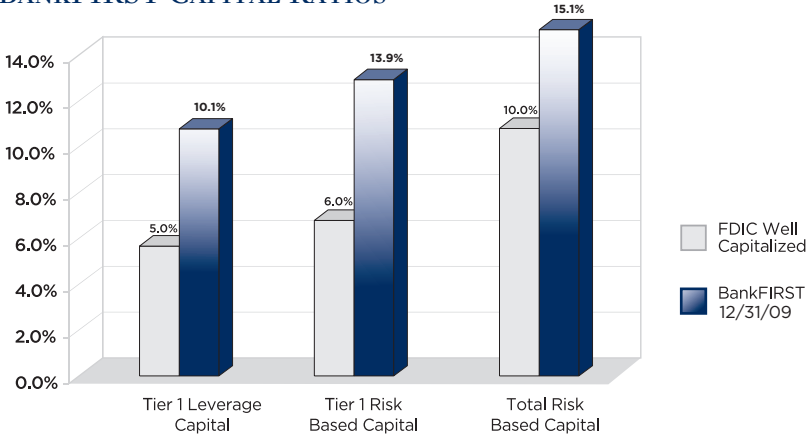
